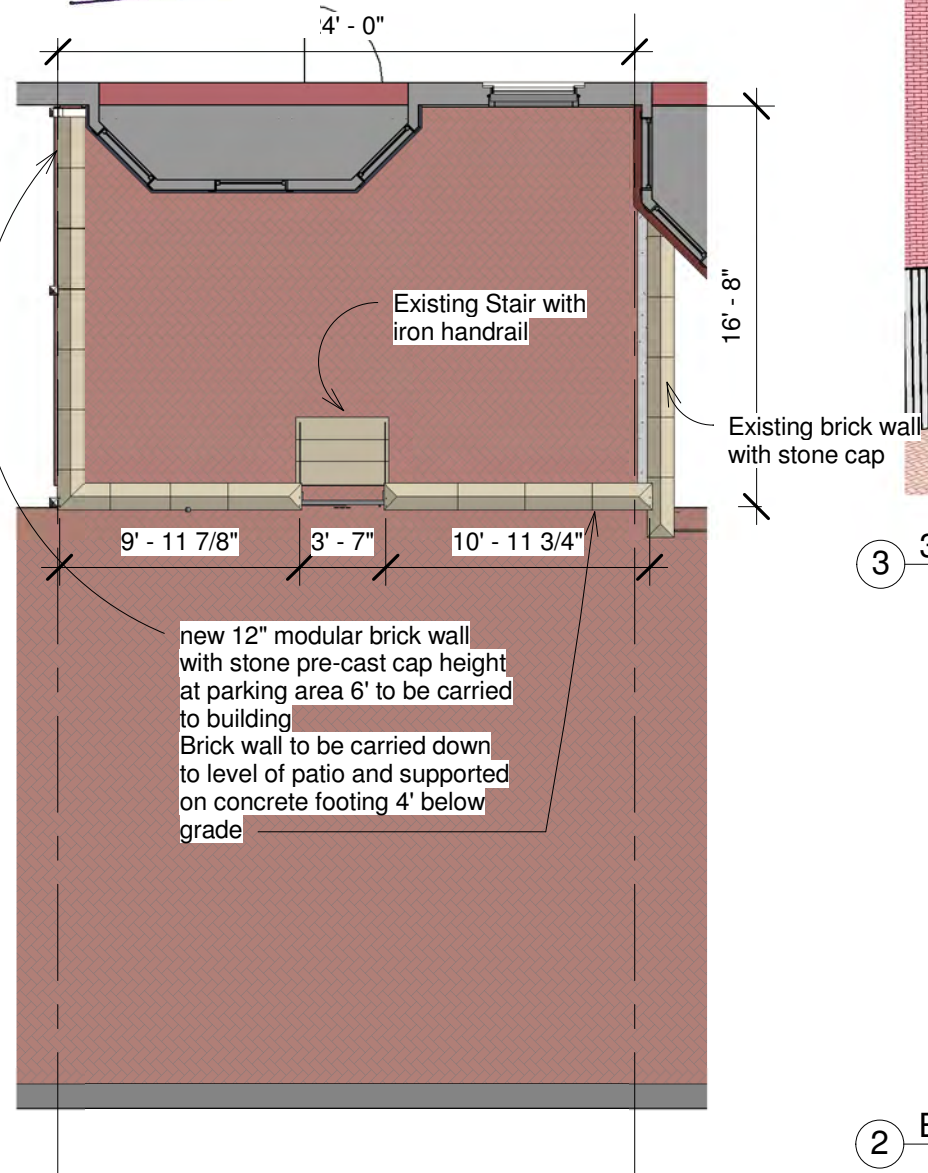
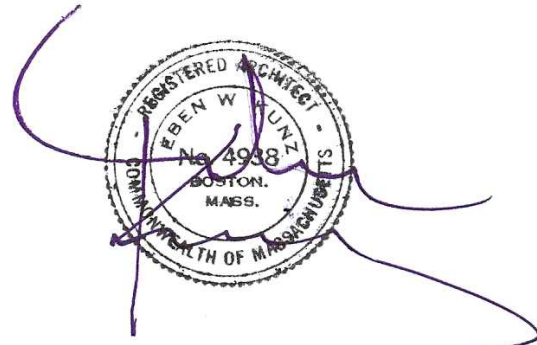
③ 3D View from Alley 427

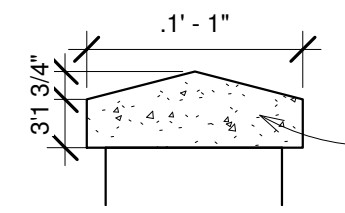

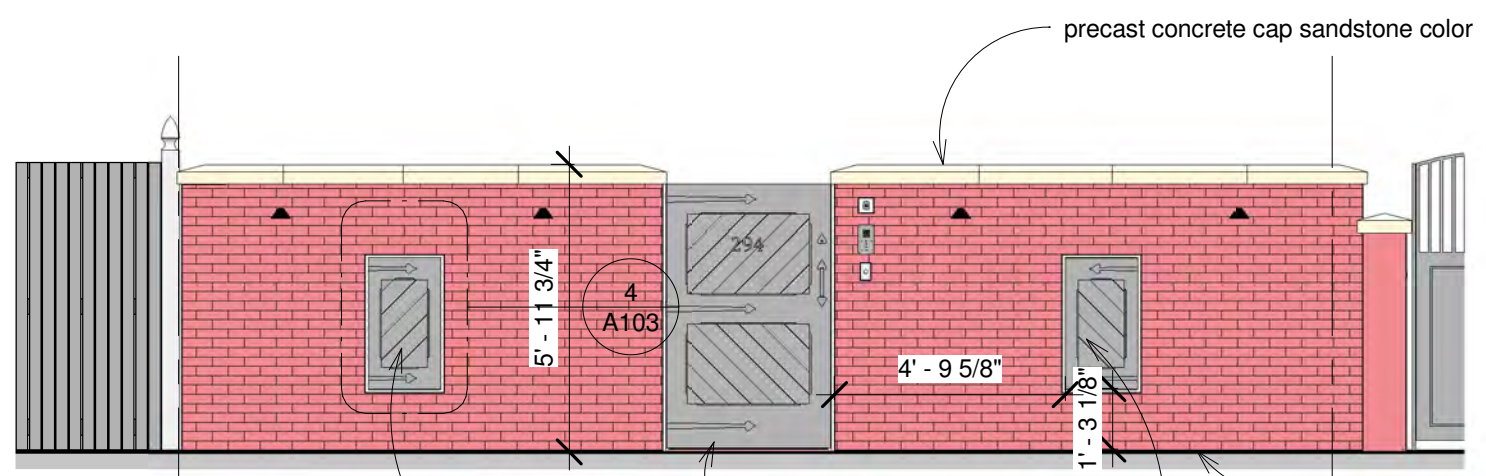


3 3D view of new patio wall

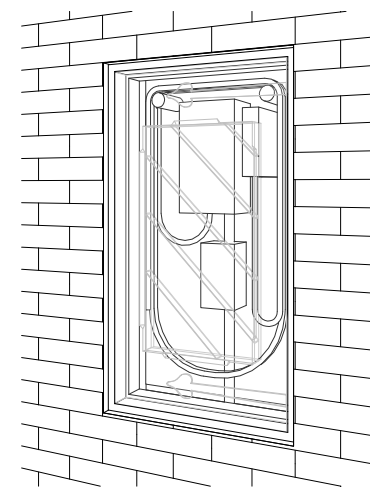


5 Plan Jamb @ hinge

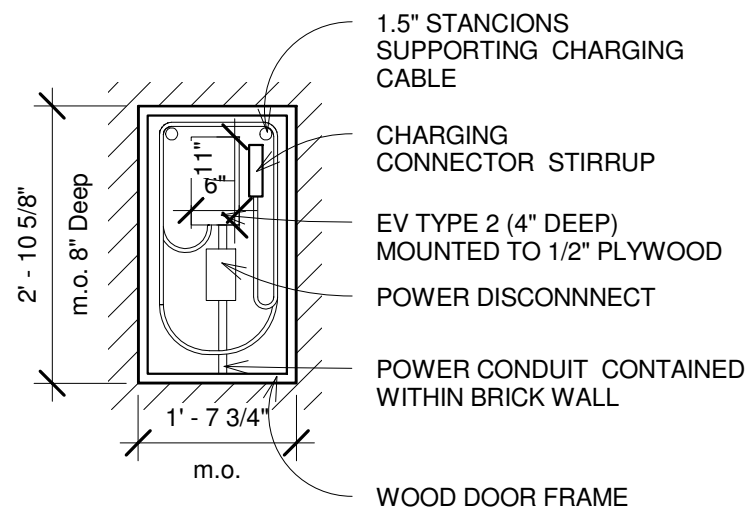


2 Gate Dimensions

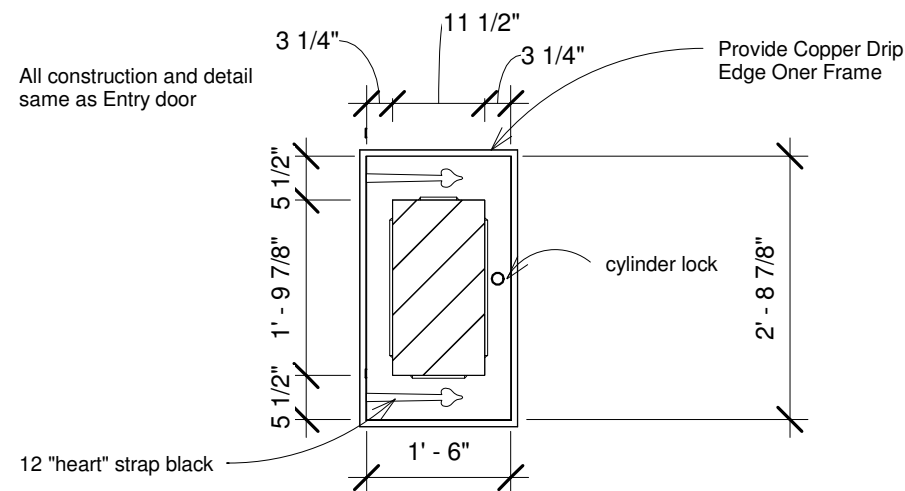
3 Gate Vertical Section

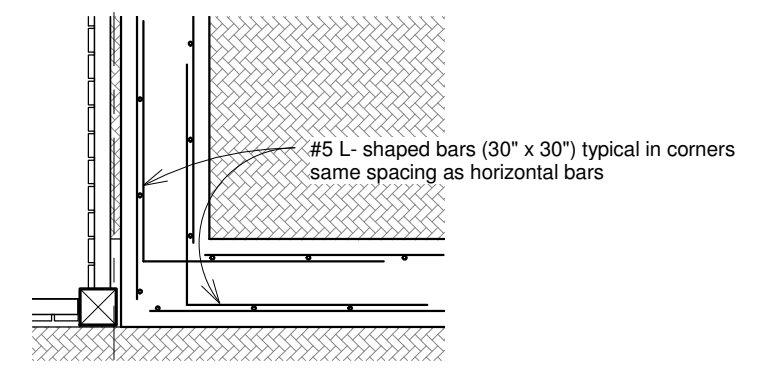
1 Typical Retaining Wall Footing
