## CITY OF BOSTON IN CITY COUNCIL

ORDER FOR A HEARING REGARDING ENERGY
DISTRIBUTION IN EAST BOSTON AND THE
LOCATION, NEED, AND SAFETY OF A PROPOSED
SUBSTATION IN THE EAGLE HILL NEIGHBORHOOD

WHEREAS: Electricity is a basic public utility and the responsible provision of affordable and

resilient utility service is critical for Boston residents;

WHEREAS: Eversource Energy intends to build an electrical substation in the Eagle Hill

neighborhood of East Boston arguing that East Boston's electrical utility

infrastructure is not sufficient;

WHEREAS: Many residents of East Boston question the need and safety of the substation being

located in the middle of a densely populated neighborhood; and

WHEREAS: The proposed substation on the East Eagle parcel directly abuts Chelsea Creek, and as

part of the Project Change Notification, Eversource recognizes the site's

susceptibility to flooding and the need to reconsider its infrastructure relative to

changes in sea level rise; and

WHEREAS: During the winter of 2018, the substation parcel and surrounding streets of Condor

and East Eagle experienced storm surge flooding three times within three months;

and

WHEREAS: The level of flooding seen on the substantial parcel is categorized by FEMA flood

maps as a 100-year event, and the Project Change Notification report does not

reference or indicate these types of storm surges as a potential threat to the integrity

of the substation and safety of residents; and

WHEREAS: During public hearings on the proposed substation, the Energy Facilities Siting Board

clearly violated the Language Access Policy and Guidelines published by the

Executive Office for Administration and Finance as Bulletin 16 and failed to

implement the Commonwealth's Environmental Justice Executive Order 552 and EJ

policy; and

WHEREAS: At a recent public meeting Eversource hosted in East Boston, Eversource refused to answer questions from the public regarding electrical capacity needs and climate resiliency, instead directing residents towards the Energy Facilities Siting Board (EFSB) filing; and

WHEREAS: Eversource has not explained the need for the substation and has not sufficiently explored alternative solutions to meeting any perceived energy demand; and

WHEREAS: The Union of Concerned Scientists has presented alternative solutions involving solar and energy storage to meet energy need while providing benefits to ratepayers; and

WHEREAS: Massport is investing \$17 million dollars in building an additional Eversource substation in East Boston less than one half mile away from the proposed Eagle Hill location; and

WHEREAS: The residents of East Boston, along with other Eversource ratepayers in Greater Boston, will pay for new electricity infrastructure, including the Eagle Hill substation, through charges included on their electric bill; and

WHEREAS: Eversource has not answered questions with regards for the need of two substations in East Boston and whether the location on Massport property could expand to serve the neighborhood and the airport; THEREFORE

## BE IT ORDERED,

That the appropriate committee of the Boston City Council holds a hearing to discuss the safety and need for the substation in East Boston, the location of the substation, the ability to use a distributed and sustainable network, the cost to ratepayers and the capacity of the planned second substation to supply the neighborhood of East Boston and that Eversource, Massport, representatives of the Walsh administration and other interested parties be invited to testify.
