This was transferred from BTD. PWD is also taking an active role in the management of wireless telecommunications in the city, including the permitting and inspection of 5G infrastructure.

Two external funds dedicated to the installation of benches throughout the City are scheduled to be complete this year. A Massachusetts Department of Energy Resources (DOER) grant will fund the installation of hybrid fuel systems throughout the City's fleet.

#### **Waste Reduction Program**

The largest portion of the Department's operating budget is Waste Reduction -- the programs that handle the trash, recycling, yard waste, food waste and household hazardous waste of every home in Boston. At the end of FY '19, the City released its Zero Waste Plan. In FY'20, we took the first major steps to make that plan a reality. This includes:

- New Contracts: All hauling and disposal contracts started anew in FY '20 without a hitch, allowing for a seamless continuity of waste services for every resident in the City.
- New Collections Hours & Days: To make collections more efficient, to reduce congestion during rush hour, and to make streets cleaner, the City successfully implemented two changes to collections hours and days. We are now starting collections at 6am; this helps trucks get main routes done before the morning rush and off the road before the afternoon rush. We also switch the North End from a Monday-Friday to a Monday-Thursday schedule, which allows for street cleaning to happen on Friday in advance of feasts and other weekend events.
- New Services: As part of the new fiscal year and the City's Zero Waste plan, we expanded our services this year. We procured two new W/MBE contracts for year-round recycling cart delivery; this extends a service that before had been only provided a portion of the year. The City also bid and will launch new programs for food waste composting and for textile collections, to get those products out of the waste stream. Finally, the City added two more weeks of curbside yard waste collection and opened up its yard waste site on American Legion Highway for weekend drop offs during spring, summer and fall.

#### **Road Construction Program**

The City's street portfolio includes over 800 miles of roadway and 1600 miles of sidewalks. We worked hard in FY 20 to keep those assets not only in a state of good repair but also designed to support our neighborhoods and businesses districts. This included:

- Nubian Square: There are over a half dozen projects completed, in design or in construction that improve almost every single block in and around Nubian Square. Totalling over \$40 million and building on past projects such as the reconstruction of the streets of Madison Park, this work in FY '20 included advancing the design of rebuild Ruggles Street, breaking ground on a rebuilt Dudley Street, reconstructing sidewalks in Orchard Gardens, rebuilding many of the streets near Water & Sewer and improving the lighting on them, and going out to bid on the complete reconstruction of Melnea Cass itself.
- Neighborhood Squares & Corridors: The City cut the ribbon on a rebuilt North Square in the North End, which was selected as one of the American Public Works Association's Public Works Projects of the year. The City also advanced the design

- of projects such as Cummins Highway, Blue Hill Ave, and other major roads throughout Boston.
- Sidewalks & Ramps: The foundation of our road program is the resurfacing of streets and the reconstruction of sidewalks and pedestrian ramps. During the last construction season, we resurfaced over 20 miles of roadway, rebuilt 1,076 ramps, and reconstructed over 481,977 square feet of sidewalks, citywide.

#### **Bridge Construction Program**

The City of Boston owns 40 bridges citywide. In one of the biggest bridge investment programs in Boston's history, seven of those bridges will be substantially reconstructed, redesigned or rehabilitated between 2018 and 2021.

Work has already been completed on the accelerated reconstruction of the Tommy Leonard Bridge (Mass. Ave. over Comm. Ave.). Deck replacement of the Alford Street Bridge is also complete. During FY'20, work proceeded on the other five major bridge projects:

- *Grimke Sisters Bridge*: The reconstruction and dedication of the Dana Ave Bridge -- now the Grimke Sisters Bridge -- was completed in FY '20. This beautiful bridge, spanning the Neponset River, now celebrates the lives of two Boston human rights leaders.
- Northern Ave Bridge: With deep engagement from the Mayor's Advisory Task Force, the City completed conceptual design on a people-first bridge crossing the Fort Point Channel at Northern Ave. Advancing the design of this bridge is a major FY 21 priority, which will allow the long-awaited construction to commence.
- Long Island Bridge: All design work on the Long Island Bridge was completed in FY '20, and the City continued to advance efforts to permit this bridge. Every decision by a third party on a permit associated with this bridge has continued to support Boston's approach.
- North Washington Street Bridge: The complete replacement of this bridge continued in FY '20. The new, redesigned bridge will significantly improve travel across the bridge -- no matter how you choose to move -- with wider sidewalks, a cycle track, a bus lane and rebuilt general travel lanes.
- Dalton Street Bridge: The City continued in FY '20 to make repairs to this bridge to extend its useful life.

#### **Central Fleet**

Central Fleet maintains and helps manage and procure a fleet of over 1,000 vehicles, used by most City Departments. Central Fleet took a number of steps this year to improve, green and right-size this fleet. This includes:

• Modernizing the Fleet: The City Fleet received 94 new vehicles in FY'20. These vehicles replaced older or disposed vehicles and will be used by departments like

Public Works, Parks, BTD and others to provide essential City services to Boston residents like snow plowing, park maintenance, and parking enforcement. This met CFM's replacement plan goal - which calls for a 10% turnover in the fleet each fiscal year to keep City vehicles operating efficiently so that departments can effectively deliver services to Boston residents.

- Electrifying the Fleet: FY'20, Central Fleet Management began working with the Mayor's Office of Environment & Energy and the Boston Transportation Department on a project to electrify the portion of the City fleet made up of light duty vehicles. To date, the City has 22 electric sedans in the fleet with an additional 20 on order for FY'21. The project calls for complete electrification of the light duty fleet where available by 2035 as well as building out the City fleet's electric vehicle charging infrastructure.
- Right-Sizing the Fleet: In FY'20, Central Fleet began working on a new vehicle utilization policy with the ultimate goal of right-sizing the City fleet and eliminating or re-assigning under-utilized vehicles and equipment. The policy calls for a committee to review vehicle usage in the City fleet that will feature representatives from multiple departments. As part of the policy, departments will receive input from CFM on electrifying and greening their fleets.

#### **Street Maintenance Program**

Delivering the exceptional basic services that residents rely on is at the heart of the Public Works mission. The FY'20 budget allows us to add few new programs and approaches to our work:

- Special Operations Team: We created a special operations team that can be deployed across Public Works districts to address specific street maintenance issues. That team has been tasked with supplementing the on-going work by the Department around Mass Ave. & Melnea Cass. This includes more thorough cleaning work on streets in adjacent neighborhoods.
- Lighting & Benches: To make streets more attractive and more appealing, particularly for seniors in our city, we've been adding benches in key locations and upgrading lighting and lighting fixtures in our neighborhoods.
- Bike Lanes: The addition of cycle tracks and parking-protected bike lanes have made cycling safer in Boston. These new facilities, however, are too narrow to be maintained with the traditional equipment and on standard routes. The Department has purchased and put to use new equipment to keep these bike lanes open both after snow storms and all year round.

#### **Delivering Exception City Services**

- Waste Reduction & Zero Waste: This year, we expect to take several major steps forward towards zero waste. This includes a new curbside food waste composting program, an expansion of our existing community curbside composting program and yard waste program, and new educational outreach efforts geared towards improving recycling practices in Boston.
- Better, Safer, Greener, Smarter Lighting: This year, we expect to make a number of improvements to our Street Lighting program, including expanding our upgrades to existing street lights, reducing stray voltage, piloting electric lights that resemble traditional gas lamps, and testing new technology to remotely monitor and manage lighting.
- Electric Vehicles: As part of a multi-year plan to green the municipal fleet, we will be making our largest purchase of electric vehicles and expanding the municipal charging infrastructure.

#### **Designing & Constructing Streets**

- Northern Avenue Bridge: Our signature capital project for this Fiscal Year will be the completion of the design for a new Northern Avenue Bridge, one that honors history, increases resiliency, improves mobility, and creates a new destination on the Fort Point Channel.
- Same or More Construction in a Shortened Construction Season: We will have a shortened CY '20 construction season. We are going to do everything we can to meet or exceed the amount of sidewalk, ramp and roadway construction that was planned for.

#### Supporting the Team

- Filling Long Term Vacancies: We will be launching a recruitment campaign for critical hard-to-fill engineer and skilled laborer positions.
- Implementing Boston's New Procurement Policies: We will work with the Office of Economic Development to implement the City's new procurement standards, expanding and improving our pool of respondents to PWD contracts.
