The Boston City Council's Committee on Public Safety & Criminal Justice will hold a public hearing on Tuesday, June 9, 2020 at 12:00 PM.

**Docket #0503, Order for hearing regarding access to wellness programs for first responders.** This matter was sponsored by Councilor Essaibi-George and was referred to the Committee on March 6, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
