The Boston City Council's Committee on Ways & Means will hold a public hearing on **Tuesday, August 18, 2020 at 3:00 PM**. This hearing was rescheduled from its original date of Wednesday, August 5, 2020. This hearing will be held virtually.

The subject of the hearing is:

***Docket #0840, order for a hearing regarding police contracts as policy documents.***

This matter was sponsored by Councilors Kenzie Bok, Andrea Campbell, and Lydia Edwards. It was referred to the Committee on July 8, 2020.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. **Attendance** In accordance with Governor Baker's March 12, 2020 Executive Order modifying certain requirements of the Open Meeting Law and relieving public bodies of certain requirements, including the requirement that public bodies conduct its meetings in a public place that is open and physically accessible to the public, the City Council will be conducting this hearing virtually. This enables the City Council to carry out its responsibilities while adhering to public health recommendations and ensuring public access to its deliberations through adequate, alternative means.
