## **COMMITTEE HEARING NOTICE**

February 12, 2021

The Boston City Council's Committee on Public Safety and Criminal Justice will hold a public hearing on **Thursday, February 18, 2021 at 9:00 AM**. This hearing will be held virtually.

Urban Area Security Initiative, awarded by the United States Department of Homeland Security, passed through the MA Executive Office of Public Safety and Security, to be administered by the Mayor's Office of Emergency Management.
