

# SOUTH END LANDMARK DISTRICT COMMISSION PUBLIC HEARING MINUTES

Lauren Bennett (The Boston Sun) announced her presence.

**5:35 PM**: Chair J. Amodeo called the public hearing to order. He explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. He also briefly explained how to participate in the online hearing.

Following this brief introduction he called the first Design Review application.

Applicant: New England Solar Hot Water, Inc.

Proposed work: At the roof install solar collectors and associated safety railings; at the side

elevation install associated piping.


**Project Representatives:** John Moore was the project representative.

**Documents Presented:** The Commission reviewed photographs of the new mockup and a map of the new location of the units. The new location has a 40" parapet which eliminates the need for a safety railing. The Commission also briefly discussed the piping but determined

Applicant: Christopher Lapan

Proposed work: At the front and rear façade which faces a public street, replace six-over-six wood windows.

**Project Representatives:** Jose Rodriguez was the project representative.

**Documents Presented:** The Commission reviewed photographs and drawings from the original application.

**Discussion Topics:** The Commissioners briefly discussed the window policy for the South End and discussed whether 6/6 or 2/2 configuration was appropriate. The basement levels were replaced approximately 10 years ago. They also discussed the existing windows and determined that the windows are not historic.

Public Comment: There was no public comment.

J. Freeman motioned to approve the application as submitted with the proviso that details and shop drawings be submitted to staff showing new construction windows. C. Hunt seconded the motion. The vote was 4-0 (Y: JA, JF, CH, DS) (N: None) (Absent: DP, FD).

Proposed work: At the front stoop and entrance, install steel railings and wood columns; and relocate downspout. See additional items under Administrative Review.



**Discussion Topics:** The Commission discussed specific details of the proposal, including the columns, cheek wall, handrails, and top rail. They also reviewed other examples of similar columns in the area.

JF motion to approve the application with the following provisos: that the columns be made more slender to match stoop walls; that the railings have returns to the at the columns and stoop wall at bottom with molded handrail with lamb's tongue profile and that the all details be submitted to staff; and that the downspout be remanded to staff and be discreet. **Discussion Topics:** The Commissioners discussed the existing deck which was constructed in 1992. They also discussed visibility from Warren Avenue and other areas.

**Public Comment:** There was no public comment.

J. Freeman motioned to remand the placement of the railings to staff with the directive that the deck be minimally visible. He also added that the any deck replacement must be treated as a new deck. He also added that any visible portions of deck must fit with the guidelines. D. Shepperd seconded the motion. The vote was 4-0 (Y: JA, JF, CH, DS) (N: None) (Absent: DP, FD).

Applicant: City of Boston, Public Facilities Department

Proposed work: Demolish a portion of the existing five story building and construct a three-story addition.

**Project Representatives:** J. Michael Sullivan was the project representative.

**Documents Presented:** The Commissioners reviewed photographs, elevation drawings, and section drawings showing the proposed plans for a new addition onto the Woods Mullen Shelter.

**Discussion Topics:** The Commissioners discussed the portions of the building affected by the proposed addition and the purview of their review. They also discussed the massing and views into the district. They also encouraged the applicants to revise the design to better harmonize with the existing Art Deco structure.

**Public Comment:** Peter Sanborn offered public comment and echoed the Commissioners' concerns.

J. Freeman motioned to approve the application for height, landscaping, setback, and massing with the request that the applicant review Commissioner comments and consider a modified massing to improve the design. Although not under SELDC







purview due to its location in the South End Harrison/ Albany Protection Area, the Commission also requested that the applicant consider Commissioner comments with regard to fenestration and proportions of the walls and incorporate if possible. C. Hunt seconded the motion. The vote was 4-0 (Y: JA, JF, CH, DS) (N: None) (Absent: DP, FD).
