Utility Pole Hearing

UP 1. On a joint petition by Verizon New England Inc. and Eversource Energy for a **Pole Installation** within **Soldiers Field Place** (public way), Brighton, to install two new utility poles to be located on its southerly side at address nos. 21 and 35, generally south of Soldiers Field Road.
