COMMISSIONER PILLSBURY MOTIONED TO APPROVE THE APPLICATION WITH PROVISOS, COMMISSIONER CAYLEY SECONDED THE MOTION. THE VOTE WAS 4-0-0 (NB, SC, KH, and HP).

#### **PROVISOS:**

- That the driveway is pushed back to the area just before the "bump out" of the home. The materials used are approved.
- That there will be footpaths in the original dimensions at the rear of the structure where one existed prior and one leading to the front door from both the sidewalk and the driveway. The remaining space must be grass or landscaped.
- That the HVAC equipment will be hidden from view with plantings and that a planting plan for the property is submitted to staff for final approval.
- That the stairs and current plantings are approved as submitted.
- That a fascia board is installed at the front stairs that matches the color of the structures trim or siding; applicant's choice.

II. ADMINISTRATIVE REVIEW/APPROVAL: In order to expedite the review process, the commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to commission staff pending ratification at its monthly public hearing. Having been identified as meeting these eligibility criteria and all applicable guidelines, the following applications will be approved at this hearing:

Following the hearing, you will be issued a Determination Sheet to present at the Inspectional Services Department (1010 Massachusetts Avenue) as proof of project approval when applying for permits. ISD personnel will send an electronic copy of your building-permit application to the commission staff for review. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents. electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness; this will be valid for one year from the date of the hearing. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.
