5:05 PM: Chair P. Vineburgh called the public hearing to order. He explained that, pursuant to the Commonwealth of Massachusetts Executive Order Suspending Certain Provisions of the Open Meeting Law, that the public hearing was being conducted virtually via the online meeting platform Zoom in order to review Design Review applications. He also briefly explained how to participate in the online hearing.

Following this brief introduction he called the first Design Review application.

I. DESIGN REVIEW

APP # 21.0816 BH ADDRESS: 46 W. CEDAR STREET

Applicant: David McMahon

Proposed Work: At rear of property, demolish ell and existing roof deck to reconstruct roof deck and el. Replace front dormer window, approve shoe scraper that are currently violations.

Project Representatives: David McMahon, Sean Cryts

Documents Presented: The Commissioners reviewed a presentation consisting of details and plans.

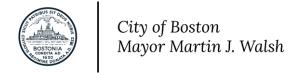
Discussion Topics: The Commission discussed the replacement of the front bay windows, and ensured that the existing fence and rear wall were to be retained.

Public Comment: Charlotte Thibodeau of the Beacon Hill Civic Association (BHCA) requested that the Commission request a mockup of the proposed rooftop addition.

- Rear wall and fence to remain
- Front dormer to be replaced with 2-over-2 wood sash windows
- Mockup of roofdeck to be constructed for staff review

ADDRESS: INTERSECTION OF BEACON & PARK STREET (Sidewalks)

Applicant: Zachary Wassmouth; Boston Public Works

Proposed Work: Install bump out and ADA accessible ramp at intersection of Park and Beacon Street. Replace brick sidewalk in front of Capitol building.

Project Representatives: Zachary Wassmouth; Boston Public Works

Documents Presented: The Commissioners reviewed a presentation consisting of details and photographs.

Discussion Topics: The Commission discussed the neighborhood context in relation to the proposed work, and confirmed that the applicant completed all necessary reviews with the Boston Transportation Department. The Commission expressed concern regarding the brick directly in front of the State House, to which the applicant stated that the brick must be ADA compliant.

Public Comment: Charlotte Thibodeau of the Beacon Hill Civic Association (BHCA) recommended approving the application. Robert Whitney stated his support for the proposed work.

A. Richmond motioned to approve the application. M. McNamara seconded the motion, and amended the motion to add a proviso. The vote was 5-0 (Y: PTV, MM, DS, AA, AR) (N: None)

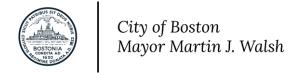
Applicant: Don Mills; Mills Whittaker Architects

Proposed Work: Replace metal downspout brackets and supports with painted copper supports.

Project Representatives: Don Mills was the project representative.

Discussion Topics: The Commissioners expressed that they felt the existing profile was more appropriate for the building than the proposed alteration.

Proposed Work: Rebuild dormer sides to within 12" of existing width to ensure structural integrity, rebuild front wood paneling, clad rebuilt dormer sides with slate shingles, replace existing shutters and hardware (where necessary) with replacements in kind, new door entry light. (See Additional Work Items Under Administrative Review).

Project Representatives: Nathaniel Walton and Timothy Burke were the project representatives.

Documents Presented: The Commissioners reviewed a presentation consisting of drawings and photographs.

Discussion Topics: The Commission discussed the proposed dormer expansion and felt it was inappropriate.

Public Comment: Charlotte Thibodeau of the Beacon Hill Civic Association (BHCA) stated her recommendation for denial of the application. Joseph Harter stated his opposition to the dormer expansion.

M. McNamara motioned to deny the proposed dormer, and remand the light fixture to staff. A. Allen seconded the motion. The vote was 5-0 (Y: PTV, MM, DS, AA, AR) (N: None)


Applicant: Michael Maler

ADDRESS: 34 IRVING STREET

Applicant: Timothy Burke

Proposed Work: Remove roof deck to replace rubber roof. Replace roof deck in exact same location.

Project Representatives: Timothy Burke and Blaine McKee were the project representatives.

Documents Presented: The Commissioners reviewed a presentation consisting of drawings and photographs.

Discussion Topics: The Commission discussed the previous approval received in 1997 for the proposed work, and had concerns about the visibility of the roof deck.

Public Comment: Charlotte Thibodeau of the Beacon Hill Civic Association (BHCA) recommended the Commission deny the application without prejudice, and suggested a mockup be constructed. Richelle Gerwitz expressed her concern about the precedent this work may set.

M. McNamara motioned to approve the application with provisos. D. Santos seconded the motion. The vote was 4-1 (Y: PTV, MM, DS, AA) (N: AR)

- Roof deck must be moved back 6 inches
- Rails to be rebuilt with black metal, remanded to staff
- Construct a mockup

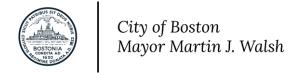

Public Comment: Charlotte Thibodeau of the Beacon Hill Civic Association (BHCA) recommended denial of the application.




