## **COMMITTEE HEARING NOTICE - Virtual Hearing**

June 29, 2021

The Boston City Council's Committee on Government Operations will hold a public hearing on Tuesday, July 6, 2021 at 11:00 AM. This hearing will be held virtually via Zoom. The subjects of the hearing are: Docket #0654, ordinance amending CBC Chapter 8-13 Ensuring Equitable Regulation of the Cannabis Industry in the City of Boston; and, Docket #0655, An Order Regarding a Text Amendment to the Boston Zoning Code with respect to Marijuana Establishments. These matters were sponsored by Councilors Lydia Edwards and Michael Flaherty and were referred to the Committee on May 12, 2021.

NOTICE: The Boston City Council may have a quorum participating due to standing committees of the City Council consisting of both voting and non-voting members. However, members participating in this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
