The Boston City Council's Committee on Public Safety & Criminal Justice will hold a public hearing on **Thursday, July 1, 2021 at 9:30 AM**. This hearing will be held virtually.

The subject of the hearing is:

Docket #0473, message and order authorizing the City of Boston to accept and expend the amount of Three Hundred Thirty Thousand Dollars (\$330,000.00) in the form of a grant, for the FY21 State Traffic Safety Information System Improvements Grant, awarded by the U.S. Department of Transportation, passed through the MA Executive Office of Public Safety, to be administered by the Police Department.

Docket #0631, message and order authorizing the City of Boston to accept and expend the amount of One Million Seven Hundred Fifty Thousand Dollars (\$1,750,000.00) in the form of a grant, for the FY21 BFD State Training Program, awarded by the Massachusetts Department of Fire Services to be administered by the Boston Fire Department.

These matters were sponsored by the Administration. They were referred to the Committee on March 31, 2021 and May 5, 2021.

However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
