## COMMITTEE HEARING NOTICE

The Boston City Council's Committee on Public Health will hold a hearing on **Wednesday, August 4, 2021 at 3:00 PM**. This hearing will be held virtually.

The subject of the hearing is:

***Docket #0811, message and order authorizing the City of Boston to accept and expend the amount of Four Hundred Eighty Thousand Dollars (\$480,000.00) in the form of a grant, awarded by BOSTON CHNA-CHIP COLLABORATIVE, to be administered by the Office of HHS.***

This matter was sponsored by the Administration, and was referred to the Committee on June 23, 2021.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
