September 7, 2021

The Boston City Council's Committee on Government Operations will hold a public hearing on Tuesday, October 5, 2021 at 2:00 PM. This hearing will be held virtually via Zoom. The subject of this hearing is: ***Docket #0685, an order regarding a text amendment to the Boston Zoning Code with respect to parking minimums for affordable housing.*** This matter was sponsored by Councilor Kenzie Bok and Councilor Matt O'Malley and was referred to the Committee on May 19, 2021.
