COMMITTEE HEARING NOTICE- Virtual Hearing

February 2, 2022

The Boston City Council's Committee on Strong Women, Families, and Communities will hold a public hearing on Monday, February 14, 2022 at 11:00 AM. This hearing will be held virtually via Zoom.

The subject of the hearing is: *Docket #0165, message and order authorizing the City of Boston to accept and expend the amount of Two Hundred Thousand Dollars (\$200,000.00) in the form of a grant for the No Kid Hungry grant, awarded by Share Our Strength to be administered by the New Urban Mechanics.* This matter was sponsored by Mayor Michelle Wu and was referred to the Committee on January 26, 2022.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
