The Boston City Council's Committee on Strong Women, Families, and Communities will hold a public hearing on Monday, February 14, 2022 at 11:00 AM. This hearing will be held virtually via Zoom.

The subject of the hearing is: Docket #0165, message and order authorizing the City of Boston to accept and expend the amount of Two Hundred Thousand Dollars (\$200,000.00) in the form of a grant for the No Kid Hungry grant, awarded by Share Our Strength to be administered by the New Urban Mechanics. This matter was sponsored by Mayor Michelle Wu and was referred to the Committee on January 26, 2022.

NOTICE: The Boston City Council may have a quorum in attendance due to standing committees of the City Council consisting of both voting and non-voting members. However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
