The subject of the hearing is: ***Docket #0313, Message and order for an appropriation order in the amount of Twenty Seven Million Two Hundred and Five Thousand Eight Hundred and Fifty Four Dollars (\$27,205,854.00) from Fiscal Year 2022 community preservation fund revenues for community preservation projects at the recommendation of the City of Boston Community Preservation Committee.*** This matter was sponsored by Mayor Wu and was referred to the Committee on March 2, 2022.
