2. Request authorization to extend the Tentative Designation status of The Cronin Group, LLC, as Redeveloper; and to enter into lease negotiations with Redeveloper to facilitate the long-term lease and redevelopment of 24 Drydock Avenue within the Raymond L. Flynn Marine Park.

- 3. Request authorization to award Tentative Designation status to and enter into lease negotiations with 22 Drydock, LLC as Redeveloper to facilitate the long-term lease and redevelopment of 20 and 22 Drydock Avenue within the Raymond L. Flynn Marine Park.
- 4. Request authorization to ratify to date, confirm and extend the Tentative Designation status of Thompson Island Outward Bound Education Center, Inc. for the redevelopment and long-term lease of EDIC Berth 10 dock and the adjacent water sheet within the Raymond L. Flynn Marine Park.
