


Individuals Receiving Initial Dose of COVID-19 Vaccine by Week, Dec. 29, 2021 - Mar. 8, 2022


Individuals Receiving Final Dose of COVID-19 Vaccine by Week, Dec. 29, 2021 - Mar. 8, 2022


Individuals with At Least 1 Dose of COVID-19 Vaccine Administered by Age Group, Dec. 15, 2020 - Mar. 8, 2022




Individuals Fully Vaccinated for COVID-19 by Age Group, Jan. 2, 2021 - Mar. 8, 2022

Percent of Individuals Fully Vaccinated for COVID-19 by Age Group, Jan. 2, 2021 - Mar. 8, 2022




Individuals with At Least 1 Dose of COVID-19 Vaccine Administered by Race/Ethnicity,




Individuals Fully Vaccinated for COVID-19 by Race/Ethnicity, Jan. 2, 2021 - Mar. 8, 2022

Percentage of Individuals Fully Vaccinated for COVID-19 by Race/Ethnicity, Jan. 2, 2021 - Mar. 8, 2022






Individuals with At Least 1 Dose of COVID-19 Vaccine Administered by Neighborhood, Dec. 15, 2020 - Mar. 8, 2022




Individuals Fully Vaccinated for COVID-19 by Neighborhood, Jan. 2, 2021 - Mar. 8, 2022
