The Boston City Council's Committee on Ways and Means will hold public hearings and working sessions on the FY23 recommended budget, as well as various relevant budget-related dockets. We have held additional spots beyond the posted hearings and working sessions schedules, according to the attached schedule. Orders for the FY23 Operating Budget, including annual appropriations for departmental operations, for the School Department, and for other post-employment benefits (OPEB).

- Docket #0480, message and order for annual appropriation and tax order for FY2023.

- Docket #0485, message and order approving an appropriation of Five Hundred Fifty Million Three Hundred Seventy Thousand Dollars (\$550,370,000.00) for the acquisition of interests in land or the acquisition of assets, or the landscaping, alteration, remediation, rehabilitation improvement of public land, the construction, reconstruction, rehabilitation, improvement, alteration, remodeling, enlargement, demolition, removal or extraordinary repairs of public buildings, facilities, assets, works or

infrastructure; for the cost of feasibility studies or engineering or architectural services for plans and specifications; for the development, design, purchase and installation of computer hardware or software and computer-assisted integrated financial management and accounting systems; and any and all costs incidental or related to the above described projects; for the purposes of various city departments including Boston Centers for Youth and Families, Department of Innovation and Technology, Environment, Fire, Neighborhood Development, Office of Arts and Culture, Parks and Recreation, Police, Property Management, Public Works and Transportation Departments, Boston Public Library, Boston Redevelopment Authority, and Public Health Commission.

Docket #0486, message and order approving an appropriation One Hundred Thirty Eight Million Five Hundred Thirty-Five Thousand Dollars (\$138,535,000.00) for the acquisition of interests in land or the acquisition of assets, or the landscaping, alteration, remediation, rehabilitation, or improvement of public land, the construction, reconstruction, rehabilitation, improvement, alteration, remodeling, enlargement, demolition, removal or extraordinary repairs of public buildings, facilities, assets, works or infrastructure; for the cost of feasibility studies or engineering or architectural services for plans and specifications; for the development, design, purchase and installation of computer hardware or software and computer-assisted integrated financial management and accounting systems; and any and all cost incidental or related to the above described projects; for the purposes of the Boston Public Schools.

- Docket #0487, message and order authorizing a limit for the Boston Public Schools revolving fund for Fiscal Year 2023 to support maintenance and repair for BPS facilities, including custodial and utility costs for extended building tie, floor refinishing, landscaping and building repairs, with expenditures not to exceed Two Million Two Hundred Thousand Dollars (\$2,200,000.00).
- Docket #0488, message and order authorizing a limit for the Boston Public Schools revolving fund for Fiscal Year 2023 for Boston Public Schools Transportation costs, including bus and public transportation costs, with expenditures not to exceed One Hundred Thousand Dollars (\$100,000.00).

and equipment necessary to operate the City Hall Child Care, with expenditures not to exceed Nine Hundred Thousand Dollars (\$900,000.00).

- Docket #0493, message and order authorizing a limit for the Mayor's Office of Arts and Culture revolving fund for Fiscal Year 2023 to purchase goods and services to support the operation of the Strand Theatre, with expenditures not to exceed Three Hundred Thousand Dollars (\$300,000.00).
- Docket #0494, message and order authorizing a limit for the Mayor's Office of Arts and Culture revolving fund for Fiscal Year 2023 to purchase goods and services to support public art to enhance the public realm throughout the City of Boston, with expenditures not to exceed One Hundred Twenty Thousand Dollars (\$120,000.00).
- Docket #0495, message and order authorizing a limit for the Mayor's Office of Tourism revolving fund for Fiscal Year 2023 to purchase goods and services to support events and programming on and around City Hall Plaza to advance tourism and promote participation in public celebrations, civic, and cultural events, with expenditures not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00).
- Docket #0496, message and order authorizing the Law Department revolving fund for Fiscal Year 2023 to purchase goods and services for repairs to city property, with expenditures not to exceed Three Hundred Thousand Dollars (\$300,000.00).
- Docket #0497, message and order authorizing a limit for the Distributed Energy Resource Revolving Fund for Fiscal Year 2023 to facilitate the purchase of offsets of greenhouse gas emissions which shall be associated with a portion of the electricity consumed by the City annually, and to operate, maintain, monitor, and expand the City's existing solar arrays and Boston Public Schools' combined heat and power facilities, with expenditures not to exceed One Hundred-Fifty Thousand Dollars (\$150,000.00).
- Docket #0498, message and order authorizing a limit for the Environment Conservation Commission revolving fund for the Fiscal Year 2023 for the purpose of securing outside consultants including engineers, wetlands scientists, wildlife biologists, or other experts in order to aid in the review of proposed projects to the Commission, per the city's ordinance protecting local wetland and promoting climate change adaptation, with expenditures not to exceed Fifty Thousand Dollars (\$50,000.00).

- Docket #0499, message and order authorizing an appropriation of Five Hundred Thousand (\$500,000) from the Boston Equity Fund to create a special revenue project grant to support equity applicants and licensees to establish and operate a cannabis business in the City of Boston, pursuant to City of Boston Ordinances Chapter 8, Section 13.
- Docket #0500, message and order authorizing an appropriation of Four Million Five Hundred Sixty Thousand Dollars (\$4,560,000.00) from the 21<sup>st</sup> Century Fund, also known as the Public, Educational, or Governmental (PEG) Access and Cable Related Fund, pursuant to Section 53F <sup>3</sup>/<sub>4</sub> of Chapter 44 of the General Laws for cable related purposes including supporting PEG access services, monitoring compliance with the cable franchise agreement, and preparation of renewal of the franchise license.
