The Boston Public Health Commission (BPHC) is the local public health department for the city of Boston. BPHC's mission is to protect, preserve, and promote the health and well-being of all Boston residents, particularly the most vulnerable populations.

BPHC is seeking request for bids from qualified vendors to provide Diesel Fuel and Oil #2. Qualified bidders are expected to begin this project promptly and complete the project on schedule to reduce any inconvenience to clients.

BPHC encourages small, local, minority, disadvantaged, women-owned, veteran and/or service-disabled owned business enterprises to participate in all procurement opportunities.

SCOPE

The Boston Public Health Commission acting by its Division of Property Management, hereinafter referred to as the awarding authority, invites bidders to submit proposal for the entitled product futures listed below. Bids shall be sealed, clearly identify as a bid, and signed by the vendor. All bids shall be titled: Long Island – Fuel Oil / Project No. LI-020-23. The Bids shall be submitted to the awarding authority representative at 205 River Street, Mattapan Campus **before 10:00 AM**, January 6 2023.

Late bids will not be accepted.

Scope of work:

- Provide a fixed price per gallon for #2 Fuel Oil for the Long Island Campus and
- Provide a cap price, with downside protection, per gallon of #2 Fuel Oil for the Long Island Campus Facilities. Please provide the formula for pricing of fuel.
- Two Pricing forms have been provided; Vendors must provide the following pricing options and/or amounts:
 - Oil No. 2 90,000 gallons
- Vendors will have additional price forms for the following:
 - Diesel fuel 5,000 gallons (stationary engines)

(Stationary Engines existing at other locations: i.e. Albany Street, Boston)

- Oil No. 2 low Bid Price does not guarantee the award for diesel. The BPHC reserve the right to consider diesel as independent bids. Vendors shall use the price form attached.
