- Waxaan caddeynaa in marka aan aqbaloo lacag bixinta kirada sida waafaqsan warqadaan,
 - Waxaan waafaqsanahay in aan dib u soo celiyo dagganaashada Ka-Qeybgalaha (haddii guri-ka-saaris kiis ah aan la buuxinin).
 - Waxaan waafaqsanahay in aan horay loo sii wadin ka-saaridda guriga taasoo ugu wacan cadadka kirada oo ey dib u bixiyeen khasnadahan waxaana aqabalayaa inaan meesha ka saaro kiis walbo oo guri ka saaris ah kaas oo ku salaysan ama raadinaya dib-uhelida lacagaha uruurey ee dib-loo-baxshey. Waxaa laga yaabaa inaan mustaqbalka keeno kiis guri ka-saaris ah haddii Ka-qeybgalaha uu ku guuldareysto inuu bixiyo kiro mustaqbalka ah oo wakhtigeeda dhaaftay kadib taariikhda abaalmarintan.

- Cutubka 151B ee Sharciyada Guud Massachusetts (Massachusetts General Laws) waxay mamnuucaan takoorka uu milkiilaha hantida u geysto daggane kasta oo qaata kaalmada guriyeynta federaalka, gobolka, ama deegaanka, kana mid ah kaalmada kirada ama dheeraadka kirada, maxaa yeelay marka qofka yahay qaataha noocaas. Diidmada milkiilaha in uu qaato kaalmada kirada degdegga, ee bixisa xisaabta idil ee laga qabo milkiilaha hantida, waxay, xaaladaha qaar, la mid tahay jebinta Cutubka 151B. Milkiileyaasha hantida waa in ay la tashtaan qareenkooda sharciga si ay u helaan waano ka hor inta aysan diidin kaalmada kirada ee bixisa dhamaan xisaabta kirada aruurtay.
