## COMMITTEE HEARING NOTICE

April 13, 2017

The Boston City Council's Committee on Ways and Means will hold a public hearing on Monday, May 18, 2017 at 12:30PM in the Iannella Chamber, 5th floor, Boston City Hall.

The subject of the hearing is:

- 0553 Message and order authorizing a limit for the Inspectional Services Department revolving fund for the Fiscal Year 2018 to reimburse for administrative costs to those City agencies which enforce CBC Chapter 16, section 1.9 and 1.9B and for costs associated with licensing and registration. This revolving fund shall be credited with receipts from all dog registrations fees collected pursuant to CBC Chapter 18, section 1.4 (6-10) and fines pursuant to CBC Chapter 16, sections 1.9 and 1.9B. Receipts and resulting expenditures from this fund shall not exceed Three Hundred Thousand Dollars (\$300,000.00).

This matter was sponsored by the Mayor, and referred to the Committee on April 12, 2017.

However, members attending this duly posted meeting are participating and deliberating only in conjunction with the business of the standing committee.
