The Boston City Council's Committee on Environment & Sustainability will hold a public hearing on **Tuesday, December 12, 2017 at 4:30PM** in the Iannella Chamber, 5th floor, Boston City Hall.

The subject of the hearing is:

1465 Messages and order authorizing the City of Boston to accept and expend the amount of Two Hundred Thousand Dollars (\$200,000.00) in the form a grant for the Beta Blocks grant from the John S. and James L. Knight Foundation to be administered by the Mayor's Office. The grant will fund experiments that aim to improve civic life by supporting Boston's efforts to create a process for deploying sensors in urban environments.

This matter was sponsored by the Mayor, and referred to the Committee on November 29, 2017.
