The Boston City Council's Committee on Ways and Means will hold a public hearing on **Monday, April 1, 2019 at 1:00 p.m.** in the Iannella Chamber, Boston City Hall, Fifth Floor.

The subjects of the hearing are:

**Docket #0501, message and order approving a supplemental appropriation for the Library Department for FY19 in the amount of Seven Hundred Thirty-Two Thousand Six Hundred Four Dollars (\$732,604.00) to cover the FY19 cost items contained within the collective bargaining agreements between the City of Boston and the Boston Public Library Professional Staff Association (PSA).**

**Docket #0502, message and order to reduce the FY19 appropriation for the Reserve for Collective Bargaining by Seven Hundred Thirty-Two Thousand Six Hundred Four Dollars (\$732,604.00) to provide funding for the Library Department for the FY19 increases contained within the collective bargaining agreements between the City of Boston and the Boston Public Library PSA.**

This matter was sponsored by Mayor Martin J. Walsh, and referred to the Committee on March 13, 2019.
