HM 1. At the request of the Public Improvement Commission staff, the Acceptance of the Minutes of the PIC hearing held on August 29, 2019.

Public Hearing

- PH 1. On a joint petition by Stuart Acquisition 12 LLC and Stuart Acquisition 22 LLC for the **Discontinuance** of any and all rights to travel the public may have had within two pedestrian easements adjacent to the following public ways in Boston Proper:
 - Shawmut Street on its northerly side at the rear of 212-22 Stuart Street, generally between Church Street and Cocoanut Grove Lane.
 - Church Street on its easterly side, generally between Stuart Street and Shawmut Street.

- Marcella Street generally between Centre Street and Thornton Street.
- Highland Street generally between John Eliot Square and Beech Glen Street.
- Cedar Street generally between Centre Street and Thornton Street.
- Centre Street generally at Highland Street, Linwood Street, and Highland Avenue.
- **Highland Avenue** generally between Centre Street and Alvah Kittredge Park.
- Linwood Street at Centre Street.
- Millmont Street generally between Highland Street and Lambert Avenue.
- Guild Street generally between Lambert Avenue and Thornton Street.
- Lambert Avenue generally between Cedar Street and Millmont Street/Guild Street.
- Thornton Street generally between Cedar Street and Vale Street.
- Valentine Street generally between Washington Street and Fulda Street.
