**CONTRACT TO THE VERTEX COMPANIES, INC.:** To provide owner's project manager services associated with the Massachusetts School Building Authority's (MSBA) 2017 Accelerated Repair Program (ARP) at Seven (7) Boston Public Schools located in Dorchester, East Boston, Roslindale and Roxbury.

Contract Price: \$30,000

That the Director be, and hereby is, authorized to request from the Mayor, in the name and on behalf of the Commission, written authority to award a contract, pursuant to the Massachusetts School Building Authority's (MSBA) guidelines for its Accelerated Repairs Program (ARP) to The Vertex Companies, Inc., a Delaware corporation, with an office located at 400 Libbey Parkway, Weymouth, MA 02189.
